Instructions for Paper Presenters

- Abstract should not be more than 250 words;
- Full paper should not be more than 7,000 words (Microsoft Word);
- Submission of full paper should include: paper title, abstract and keywords (not more than five words); and references in APA reference style (version 6)
- Authors should clearly state their mailing address, telephone number and email address (Corresponding author should be stated in case of multiple authorship)

Conference Fees /MCPE Credit Hours
