Instructions for Paper Presenters

- Abstract should not be more than 250 words;
- Full paper should not be more than 7,000 words, Times New Roman in 12 fonts (Microsoft Word);
- Submission of full paper should include: paper title, abstract and keywords (not more than five words) and references in APA reference style (version 6);
- Authors should clearly state their mailing address, telephone number and email address (Corresponding author should be stated in case of multiple authorship); and
- Paper presentations would commence immediately after the opening ceremony.

Conference Fees /MCPD Credit Hours

- The conference fee is ₦35,000.00 (Foreign Delegate: \$100) which covers conference bag, a hard copy of conference book of abstract, lunch and tea break;
- Virtual paper presentation fee is ₦25,000.00;
- Non-paper presenting physical delegates ₦25,000.00 which covers conference materials;
- Non-paper presenting virtual delegates for concurrent sessions will pay ₦15,000 (will get certificate & credit hrs only);
- Institutional Group registration of 5 participants & above, attracts 10% discount;
- Early bird registration on or before January 31, 2023 attracts 10% discount;
- Certificates of attendance shall be issued to all participants; and
- ICAN members who attend shall earn 13 credit hours while members who make presentations shall earn 16 credit hours.

Colloquium

- Ph.D. candidates are expected to present their proposals before the conference delegates.
- Assessment shall be based on the following criteria:
clarity of the research problem, critical literature review, appropriateness of the methodology, expected contribution to knowledge, originality, language style, creativity and coherence
- The colloquium will be held at Peter Mbah Law Auditorium on February 15, 2023 at 4pm.
- Prizes shall be awarded to the best 2 Ph.D. colloquium presenters during the closing ceremony
