# 21st CONFERMENT OF FELLOWSHIP STATUS CEREMONY

The Fellowship Status of the Institute of Chartered Accountants of Nigeria (ICAN) is the highest designation a member can attain in his/her professional career as a Chartered Accountant. The Conferment Ceremony holds once every year and the next edition will hold as follows: Venue: Landmark Event Centre, Plot 3 & 4, Water Corporation Drive, off Ligali Ayorinde Street, Oniru, Victoria Island, Lagos Date: Saturday, April 01, 2023 at 10:00am.

## 1. ELIGIBILITY:

Members in the following categories are eligible for transfer to Fellowship in 2023:

- Members in Practice: An eligible member in this category must:
  - i. hold a Licence to Practise for 5 years issued on or before January 1, 2018, and
  - ii. be in continuous practice, using the Licence, on his/her own or in partnership with other Accountants.
- b. Members not in Practice: An eligible member in this category must have enrolled as Associate (inducted) not less than 10 years immediately preceding the date of next Conferment Ceremony i.e. on or before May 31, 2013.
- c. Eligible members in a & b above MUST be financial members of the Institute and District Society.

#### 2. FEES:

a. Participant only (Physical):	<del>N</del> 140,000
b. Participant with one guest (Physical):	N150,000
c. Participant only (Virtual):	N130,000

### 3. PROCEDURES FOR APPLICATION

- a. Application is **STRICTLY and exclusively online**.
- b. Pay Direct: Pay at any commercial bank and go to www.icanonline-ngr.com/paydirect for online application.
- c. Quickteller: Go to www.quickteller.com/ican to pay and proceed to complete the online application
- d. WebPay: Go to <u>https://icanportal.org/members/paymasters</u> to pay and proceed to complete the online application.
- e. Copy this link <u>www.icanportal.org/members/districtclearances</u> and send to the Chairman or Secretary of your District Society for endorsement of your application. See link for District Directory <u>https://icanig.org/members/documents/dds 18012023.pdf</u>
- f. Print/Save the approval page for your record.

#### NOTE

- I. Eligible members willing to come with guest are allowed to pay the additional N10,000 for only one guest (optional) as stated in 2b above
- II. After payment, the fellowship application must be completed by following the procedures on item 3 above.
- III. Eligible members must belong to a District and must pay all outstanding Membership & District Society dues before applying.
- IV. Eligible female members wishing to change their surname on marital grounds must do so before applying for fellowship.
- V. Payment and online application will close on Friday, March 17, 2023.
- VI. Friends and well-wishers may place congratulatory messages/adverts in the Brochure at the cost of ¥25,000 (full page) and ¥15,000 (half page). Payment evidence and advert artwork(In JPEG format ) must reach the Institute on or before

Friday, March 17, 2023. Congratulatory message/Advert artwork should be sent through fellowship@ican.org.ng ONLY
