The following categories of members are eligible for transfer to Fellowship status in 2026:

- (a) Members in Practice: An eligible member must:
- Hold a valid Practice Licence issued on or before January 1, 2021, with a minimum of five (5) years' tenure.
 - Have been in continuous practice under a valid licence for at least five (5) years.
- (b) Members Not in Practice: An eligible member must have been inducted as an Associate (ACA) not less than ten (10) years prior to the date of the next conferment ceremony, that is, on or before November 2015.
