

Dear Esteemed member,

In compliance with the Institute's policy aimed at protecting the value of our practice licences, we hereby request for confidential information from you on the members listed below who have recently applied for the Institute's practice licence.

The information we require are strictly restricted to:

1. Whether any of the practice licence sponsors is not in full-time practice in an ICAN-registered audit firm and so, unqualified to sponsor a practice licence candidate; and
2. Whether any of the practice licence candidates has not obtained the required minimum of 36 months full-time and continuous training in an ICAN-registered firm.
