

REQUEST FOR MEMBERS' SCRUTINY OF NEW PRACTICE LICENCE CANDIDATES

Dear Member,

Sequel to the new practice licence guidelines recently approved by Council to improve the Institute's practice licensing processes, we hereby respectfully request for confidential information from members on the submissions made by fresh practice licence candidates listed below.

The information we require are strictly restricted to:

- i. Whether any of the practice licence sponsors is not in full-time practice in an ICAN-registered audit firm and so, unqualified to sponsor a practice licence candidate; and
- ii. Whether any of the practice licence candidates has not obtained the required minimum of 36 months full-time and continuous training in an ICAN –registered firm.
