



### Launch a startup

You need to know whether the business will make money, convince investors and lenders of the same thing. Also register business with the **Corporate Affairs Commission (CAC), obtain Tax** identification Numbers (TIN) and provide advice on government regulatory requirements for business entities. Chartered Accountant can write a credible business plan, help identify cheapest source of funds.


